Conditions of Entry: Entry is conditional upon acceptance of these conditions.

1. Entering this event constitutes acknowledgement that PCV rules apply and acceptance of these rules.
2. The organising committee reserves the right to cancel any class; *divide any class; alter times; refuse any entry with or without stating the reason.*
3. BEFORE RIDING ALL OPEN riders must complete and submit a LIABILITY DECLARATION FORM - see below and available on the day. A \$10 DAY PARTICIPANT FEE is also payable UNLESS proof of current financial membership to PCAV, EV/EA, HRCAV, AHSA, AERA, SHCA, Interstate Pony Club OR can provide proof of personal liability cover of at least \$10,000,000. If you ARE required to pay the \$10 day participation fee, you MUST also complete a DAY PARTICIPANT WAIVER – see below and available on the day; Competitors may ride more than one horse, subject to the conditions of PCAV *Handbook of Bylaws* Multiple Horse Rules. Please indicate on entry order of preference as Multiple Horses only allowed if numbers permit.
4. Before Riding, all Pony Club riders must present their PCV membership card.
5. **Medical Armbands must be worn by both OPEN and Pony Club riders and present at gear check.**
6. **Freshman's Showjumping and XC Training is not a competition.**
7. Dogs are prohibited without exception.
8. No Smoking allowed on the Grounds at any time.
9. Queries, protests, horse abuse and doping rules as per the PCAV *Handbook of By-Laws*.
10. Horses must be at least age four, no stallions, colts or rigs.
11. Lunging only allowed in designated lunging area. Only 1 horse allowed in lunging area at a time.
12. Neither the organising committee nor PCV accepts any responsibility whatsoever for any accident, damage, injury or illness to horses, ground spectators, or any other persons or property.
13. Entry only on the day, no refund will be applicable for unused tickets.
14. Gear check is required prior to XC Training and/or Freshman's Showjumping.
15. **Riders who have more than 3 refusals at same jump on XC must move on to next jump if requested by Instructor/Club Official**
16. ALL riders must wear "standards approved" complying helmets as specified in the current PCV gear rules. Spot checks may occur and incorrect helmets will incur elimination. Complying helmets are AS/NZS 3838(AU), ASTM F 1163(USA), PAS 015(UK), VG1(EUROPE), EN 1384(EUROPE) only up to and including 2015, if made in 2016 is not acceptable unless also complies with VG1;
