All Riders competing in an Open section must complete a Liability Declaration form

Conditions of Entry: Entry is conditional upon acceptance of these conditions.

1. Entering this competition constitutes acknowledgement that PCAV rules apply and acceptance of these rules.
2. For Pony Club sections PCAV membership card must be presented to the secretary's office for inspection before riding.
3. Before riding, all competitors in the Open Section/s must sign a Public Liability Declaration form 2016-2017 with the event secretary. A \$10 Fee is due UNLESS you are a financial member* of EV/EA; AHS; SHCA; AERA; an Interstate Pony Club; or can prove personal Liability Cover of at least \$10,000,000.
***Must produce proof.**
Riders without adequate Insurance Cover pay \$10 for Liability Only cover for the duration of the event. (Not personal Medical) and complete the Day Participant Waiver 2016-2017.
4. For pony club members, in Open Sections, on presentation of your PCAV membership card payment of the Day Attendance Fee will be waived.
5. The organizing committee reserves the right to cancel any class or competition; divide any class; alter times; refuse any entry with or without stating the reason.
6. No refunds after the closing date except with vet or medical certificate. A \$10 handling fee will be retained from ALL refunds.
7. Competitors may ride more than one horse, subject to the conditions of PCAV *Handbook of Bylaws Multiple Horse Rules*.
8. Medical Armbands must be worn by all competitors and presented at gear check. (applies to both PCAV and non-PCAV members).
9. **Gear check before riding in each section of this competition is required.**
10. Dogs are prohibited without exception.
11. Queries, protests, horse abuse and doping rules as per the PCAV *Handbook of By-Laws*.
12. Horses must be at least age four, no stallions, colts or rigs.
13. **Competitors to supply own back number holders.**
14. Lunging only allowed in designated Lunging area. Only 1 horse allowed in the area at a time.
15. Neither the organizing committee of this competition nor the PCAV accepts any responsibility whatsoever for any accident, damage, injury or illness to horses, ground spectators, or any other persons or property
