Dressage tests (PCAV 2013)

Combined Training 1C, 2C, 3C, 4C, 5C, 5A Horse Trials 1B, 2B, 3B, 4B, 5B

60 x 20 m arenas for grades 1, 2 & 3, 40 x 20m for grades 4 & 5

Riders must provide own back number holders, numbers to be provided by SPC

A helper for the cross country is required for every 3 entries from the same club please.

Prizes: Horse Trials PC and Open - Trophy & Sash for 1st place, Sashes to 6th Place
 Horse Trials Best Dressage PC and Open - Sash
 Combined Training – PC and Open - Sashes 1st to 6th Place. Grade 6 – all
 competitors receive a ribbon.

(No equal placings in Open classes. Placings to 4th for classes of 12 entries or less)

Entry Fees:

<u>Horse Trials</u>	\$55 - Pony Club Grades, (This includes the WYEC Facility Fee)	\$70 - Open Grades
<u>Combined Training</u>	\$35 Pony Club Grades (This includes the WYEC Facility Fee)	\$45 Open Grades

- Add \$10 per day for Non PCAV, EA, AHS, AERA, HRCV or interstate Pony Club
- Camping \$15 per family for the weekend, non-powered sites (full bathroom facilities available)
- Yards may be reserved at a cost of \$10 for the weekend

CONDITIONS OF ENTRY: Entry is conditional upon acceptance of these conditions

1. Entering this competition constitutes acknowledgement that PCAV rules apply, and acceptance of these rules.
2. **\$10 per day** Insurance if not a member of EA; AHS; AERA; HRCav; PCAV or interstate pony club; or you can prove personal Liability Cover of at least \$10,000,000. **If proof of membership of one of the listed clubs is not presented for competitors in the Open Section the \$10 per day fee must be paid.**
3. All Open competitors must fill in the "Liability Declaration Form". The form can be found on the PCAV website and with the entry form on horsecomps.com.au. PCAV Insurance Policy specifically states anyone not following PCAV Rules may be left uninsured
4. The organising committee reserves the right to cancel any class or competition; divide any class; alter times; refuse any entry with or without stating the reason.
5. No refunds after closing date except with vet or medical certificate.
6. Competitors may ride more than one horse competitively in all grades subject to ballot of entries. Preferences will be given to grades 1, 2 & 3 and based on listed order on entry form.
7. PCAV membership cards must be presented and handed in at the event office before riding.
8. Approved AUS/NZ 3838, EN1384, ASTM F1163, ARB HS 2012, AS+PAS 015, VG 01.040 riding helmets must be worn in all phases. (Spot checks to ensure compliance may occur)
9. Armbands must be worn by all riders and inspected at gear check.
10. ***Gear check is required before each phase.***
11. Queries, protests, horse abuse rules as per the PCAV *Handbook of By-Laws*.
12. Dogs are prohibited. Guide dogs, carers/companion dogs and the like required for health reasons are accepted.
13. Riders under eight years of age may not compete in the Horse Trials, Riders under seven years of age may not compete in the Combined Training, Riders in the PC grade 6 must not be over 10 years of age. Horses must be at least aged four. No stallions, colts or rigs.
14. **Competitor numbers: All riders MUST provide their own back number holders, organising committee will supply numbers.** Back numbers must be used for cross country. Bridle or saddle blanket numbers OK for dressage and showjumping.
15. Lunging is only permitted in designated areas as per PCAV Lunging Policy.
16. PCV Alcohol Policy Applies.
17. Neither the organising committee of this competition nor the PCAV accepts any responsibility whatsoever for any accident, damage, injury or illness to horses, riders, ground spectators or any other person or property.
18. Yards may be reserved at a cost of \$10 per yard per horse. These can be reserved by completing the form on horsecomps.com.au. Portable yards must comply with PCAV requirements. The use of electrified tape, strings, ropes or chains, is not permitted at Pony Club Events. Electric tape can be used as a top line or as a "standoff" on a steel or solid yard, but not as a standalone yard.
