### Conditions of Entry

1. PCAV club cards member cards must be inspected at the Secretary's office before riding (PCV Insurance Policy states anyone not following PCV Rules may be left uninsured).
2. No refunds after closing date except with vet or medical certificate. An admin fee of \$10 will be deducted.
3. Entering this competition constitutes acknowledgement that PCV rules apply and acceptance of these rules.
4. The organising committee reserves the right to cancel any class or competition; divide any class; alter times; refuse any entry with or without stating the reason.
5. Competitors may ride more than one horse subject to the conditions of PCV Handbook of By-Laws multiple horse rules
6. Gear Check required for all riders
7. All riders must wear complying helmets. Spot checks to ensure compliance may occur. Elimination will apply for incorrect helmet standards number.
8. Medical Armbands to be worn by all competitors.
9. Queries, protests, horse abuse rules as per the PCV Handbook of By-Laws.
10. Horses must be at least age four, no stallions, colts or rigs. A horse may only be ridden by one rider
11. Competitors must provide their own bridle or saddle blanket numbers
12. PCV Alcohol Policy applies.
13. PCV Lungeing Policy applies.
14. Neither the organising committee of this competition nor the PCV accepts any responsibility whatsoever for any accident, damage, injury or illness to horses, riders, ground spectators or any other property
